3. Matters arising from the minutes: None

4. Reports:

Cricket Club: The club has fixtures to the end of September. A potential clash with Youth Football was identified (post meeting note – this has been resolved and the cricket team will be playing away). A Practice net has been purchased (see below). The track prepared for the youth has been used on a regular basis during the season by a variety of youngsters.

The undergrowth around the edge of the Rec and around the container had been carried out by Harmers.

The meeting agreed to make a further request to the Parish Council that the undergrowth by the container be cut back again, that the whole of the recreation ground and area around container be treated with weed killer in the early spring and that strimming around the edge of the recreation ground be continued. Spartans FC: Nothing to report

Youth Football: The club has 3 different age group teams each requiring a different size pitch. Concern was expressed about the marking of a pitch to the side of the cricket square. MH and MLY to look at the possible use of coloured line marker so that one pitch can be marked out on top of another pitch at the end of the cricket square leaving the area to the side of the square unmarked.

The club would like to site a small container, preferably adjacent to the Spartans changing room to store their equipment. This would need to be approved by the Parish Council after consultation with SF.

The club would like to purchase a set of goal posts. The possibility of the Parish Council providing some financial support was discussed and CW advised that a

written proposal would be required and presented to the Parish Council, via the Clerk, in advance of a meeting so that it could be placed on the agenda for decision making.

The Parish Council agreed that the club be allowed to secure, with padlocks, the nets to the basketball court 'netting' when not in use.
